ENT ENVIRONMENT & MANAGEMENT



ENT is a **social economic initiative** that is formed by 2 organisations: a consultancy (**ENT Environment and Management**) and a foundation (**Fundació ENT**), y que actúa de centro de investigación en innovación ambiental.

Both institutions are integrated by a **multidisciplinary group of highly trained and experienced professionals** dedicated to the elaboration, analysis and implementation of public environmental policies.

We work, in most cases, for public administrations, and also for **non profit organisations**: NGOs, trade unions, universities, etc., but we also carry out projects with for profit initiatives if we share the same values.

We participate in several national and **international networks** that share our same goals, as ACR+, MedReAct or Seas At Risk.

We try to **be innovative** in the majority of our projects, and we also participate in a number of research and development projects. We then disseminate the results in peer-reviewed scientific publications and through the participation in conferences.

Our management is orientated to **client satisfaction and environmentally efficient management**, so that ENT - environment and management- has **ISO certificates** 9001:2015 (certificate num. ES084071-1) and 14001:2015 (certificat num. ES084072-1), issued by the certification body Bureau Veritas Certification, S.A.

We have our headquarters in Vilanova i la Geltrú (Barcelona) but **we work globally**, although most of our work is currently in Europe, through the implementation of projects at various levels: local, regional, national and EU-wide.

ENT has an **extensive experience in the development of projects of consultancy, research and cooperation for development**. We have carried them out individually as well as being integrated in consortia. Our previous experience covers the areas of **economics and the environmental, waste, energy and climate change, marine area and political ecology**.



In our planning of activities we want to deepen our **international work**, for this reason we are open to establish collaborations with public organisations, foundations, universities, companies and other entities, mainly from Europe and Latin America to participate in public tenders, framework programmes, and European Commission Tenders and of other international and multilateral organizations working in these areas.
